



Visiting the Supreme Court of Ohio

BUS DROP-OFF/PICK-UP INSTRUCTIONS

To ensure students do not have to cross the street and to avoid blocking traffic, buses should head north on Civic Center Drive towards Broad Street and drop-off or pick-up students next to the tour group entrance. This may require driving south on Front Street past the building's main entrance, turning right (west) onto Town or Rich Street, and turning right (north) onto Civic Center Drive. There are two bus slips beside the building where buses may temporarily park.

City of Columbus transportation officials prohibit bus parking along Civic Center Drive. This is strictly enforced. Bus parking is available for a fee at the National Veterans Memorial and Museum, located at 300 W. Broad Street, just across the Scioto River from the Moyer Judicial Center. - **From the North:** Take I-71 S to I-670 W (exit 109A); go west and follow to exit 4B (US-23 S/N 3rd St). Continue on 3rd Street for about four blocks to Broad Street. Turn right onto Broad Street and continue two blocks to Front Street. Turn left onto Front Street and the Moyer Judicial Center will be the second building on your right.
- **From the South:** Take I-71 N to OH-315 N (exit 106). Exit at US-62/OH-3/Rich Street toward Town Street (exit 1A). Turn right onto Rich Street. Make a slight right onto West Main Street. Turn left onto South Front Street. The Moyer Judicial Center is on the left.
- **From the East:** Take I-70 W to exit 101B (Downtown). Continue on E. Mound Street for about six blocks. Turn right onto Front Street and continue about five more blocks. The Moyer Judicial Center will be on your left.
- **From the West:** Take I-70-E to I-670-E toward the Airport (exit 96). Take Exit 2A for US-33 S toward OH-315 S. Turn right onto US-33 E/Dublin Road. Turn right onto Marconi Boulevard. Turn left onto West Broad Street. Turn right at the first cross street onto South Front Street. The Moyer Judicial Center will be on the right.



Note: Front Street and Civic Center Drive are two-way streets.
